By signing below, you agree to be bound by the Club rules and that it is your responsibility to read and abide by the Club's safety policies which are contained in the Club rule book and risk assessment.

**Note to parents, guardians and carers:** Whilst this Club has a moral duty and statutory duty to take all reasonable steps to ensure the general welfare and protection of children an vulnerable adult members, in particular during the actual act of model aircraft flying and associated pre-flight and post-flight procedures, the Club will not undertake the all encompassing responsibilities of those acting in the role of guardians or carers unless specifically arranged.

Should your child have any special medical or physical needs, you are required to advise the Club in writing. Should physical contact be required during model flying for instructional or any other purposes, these will be explained to you and you will be required to record your agreement in writing defining the type and limits of contact.

The Club will not use a photographic image of your child without express consent. In addition, this Club has specific rules and policies relating to children and vulnerable adults, which has been provided to you as part of the Phoenix Model Flying club (Dorset) Rules. You are required to study it carefully, in particular the "Guide for the Parents", Guardians and Carers of Children and Vulnerable Adults".

Junior members under the age of 16 years will not be permitted to fly without supervision even if they hold a current BMFA qualification.

This membership form must be countersigned by the parent or guardian if the applicant is less than 18 years of age or by the authorised carer of a vulnerable adult, thereby signifying acceptance of the conditions of membership.
